NARRATIVE
<p>I filed a lawsuit against Marshall Taylor (et al.) Also known as Marshall Taylor PLLC. The principle (Marshall Taylor) has a lot of aliases. In 2023 I filed a domestic violence protective order against my ex-wife ... abusive Litigation was committed by Marshall Taylor, fraud on the court, perjury on Judge Steven's and concealing criminal elements of deponent. I filed suit on 10/18/2024, he failed to respond, his counsel failed to answer, meanwhile in New York, I filed 3 orders to show cause against my ex-wife (identity theft). Had a hearing on December 5, 2024.</p> <p>Somehow all my filings in New York (all papers, and exhibits) disappeared and the record presented to judge Walter, so Dana and Taylor are communicating. Taylor's portions of the case in 2023, and 2024 was at the hearing on the December 5, 2024. I just prevailed over Marshall Taylor on default (awaiting clerk entry) 24cv033531-910, so Dana Herrington testified to false documents stating i served to my ex. I want him arrested for fraud on court and lying to judge stevens, conspiracy to tamper with litigation (in there's a crime) and create confusion in the court.
